Women taking Fosomax are at an increased risk of developing osteonecrosis of the jaw. This condition may cause pain, swelling or infection of the gums, loosening of the teeth, poor healing of the gums, numbness or a

feeling of heaviness in the jaw, drainage and exposed bone.

Patients in the most serious cases may require the removal of sections of the jaw.
